



## 2-3-2 Cohesive Strategy Partnership Draft Tribal and Traditional Communities Engagement Strategy

*This Draft Tribal and Traditional Communities Engagement Strategy reflects the priorities described by those in attendance at the February 6<sup>th</sup>, 2024 Tribal and Traditional Communities engagement subgroup meeting in Abiquiu, New Mexico. The intent of this engagement strategy is to support targeted coordination of project partners of the 2-3-2 throughout the life of the Rio Chama CFLRP towards priority actions documented herein.*

*Priority actions were placed into three broad categories based on the preliminary research of Lily Calfee, CSU. Categories included: Trust-building; Programs, Projects, and Financial Mechanisms; and Transfer of Power. Priority actions were further categorized as working or emerging to account for the fact that some of these items are already underway in the Rio Chama CFLRP landscape.*

*Priorities were ranked by participants (in red) and they are documented here with higher-ranked priorities at the top. These rankings are meant to represent the level of interest and capacity that participants stated for engaging with a specific list item and not the inherent value of a list item. This document will undergo further revision and will be open to rolling updates, as needed.*
