Join us in Pagosa Springs, where we will explore the scales of monitoring at play in this part of our landscape. From community bird monitoring to the national Adaptive Silviculture for Climate Change program, come learn with us. We will spend most of the day outside at Jackson Mountain on the San Juan National Forest, and at Reservoir Hill in the Town of Pagosa Springs, right on the San Juan River (one of the “three rivers” in our name).

3. Celebrate local partnerships and strengthen relationships through shared field experiences and informal connection.
